Sub: Notification of Result for recruitment to the posts of Technical Assistant (Pay Level-6) vide IITR Advertisement No: IITR/01/2024 - reg.

Notification for filling up 08 vacancies of Technical Assistants, against 08 post codes, was issued vide IITR Advertisement No: IITR/01/2024 dated 26.02.2024.

- 2. Total 411 applications were received against 08 vacancies. Out of 411, total 122 candidates were shortlisted for appearing in Trade Test. The List of Shortlisted candidates was issued vide this office notice of even number dated 07.12.2024 and 17.12.2024.
- 3. Trade Tests were conducted on 28.12.2024 at I.E.T Lucknow for post code TA2 and TA3 and for Post Code TA1, TA4 to TA8 on 18.01.2025 at IITR, Lucknow. Total 51 candidates were declared qualified in Trade Test as notified vide IITR notice of even number dated 10.01.2025 and 18.01.2025.
- 4. The Written examination was conducted on 19.01.2025 at CSIR-IITR, Lucknow. Out of 51, total 49 candidates appeared in Written Examination. There were three papers (Paper-I, Paper-II and Paper-III) for Written Examination. As per advertisement and selection process for these posts Paper-I is qualifying in nature. Final merit has been drawn on the basis of the aggregate marks obtained by the candidates in Paper-II and Paper-III.
- 5. Representations received from the candidates with regard to the tentative Answer Keys of Paper-I, Paper-II and Paper-III of the Examination have been carefully examined and the Answer Keys have been modified wherever necessary. The Final Answer Keys (enclosed) have been used for evaluation of OMR sheets accordingly.
- 6. The Selection Committee which met on 25.10.2024 and 16.01.2025 fixed the following threshold marks in Paper-I (for all 08 post codes) for evaluation of Paper-II and Paper-III. Further, The Selection Committee fixed the following threshold marks in Paper-II and Paper-III for further consideration for selection against advertised Posts which are as follows:
