Paper-II & Paper-III will be evaluated only for those candidates who secure the minimum threshold marks (to be determined by Selection Committee) in Paper-I. The final merit list will be prepared on the basis of the marks obtained by the candidates in Paper-II & Paper-III.
6. Written examination will start at 09:30AM and will be of 03 hours. No candidate shall be allowed to appear for examination once the examination will start.
7. The Admit Cards for Written Examination for candidates will be provided at CSIR-IITR. Hence, the candidates are requested to reach the examination centre on time with a valid ID Proof along with signed photocopy of the ID.
