- 4. There will be three OMR based Multiple Choice Question Papers (Paper-I, Paper-II & Paper-III). Paper-III & Paper-III will be evaluated only for those candidates who secure the minimum threshold marks (published vide Notice dated 26.07.2025) in Paper-I. The Final Merit List will be prepared for the candidates who secure minimum Threshold Marks (published vide Notice dated 26.07.2025) in Paper-II and Paper-III in aggregate. Syllabus of Written examination has already been notified on this institute's website vide notice dated 18.07.2025.
- 5. Reporting time for the candidate for written exam on **02.08.2025** (Saturday) shall be **8.00** AM. Written examination will be of 02 hours 30 minutes. No candidate shall be allowed to appear for examination once the examination gets start.
- 6. Document Verification for the candidates appearing for the Competitive Written Examination for the post code (TEC1 to TEC7) will be done before the scheduled Written Examination on 02.08.2025 (Saturday) at CSIR-Indian Institute of Toxicology Research (CSIR-IITR) 31 MG Marg, Lucknow. Hence, applicants are requested to bring all your essential and necessary documents in original. Photograph/Images of original documents in Mobile phone/Tablet will not be considered.
- 7. Candidates will be required to produce the relevant document (in original) such as:
 - Date of Birth Proof (if not mentioned in Matriculation/ Secondary Certificate and Marksheet).
 - Matriculation/ Secondary Certificate and Marksheet.
 - Any other Educational Qualification Certificate / ITI Marksheet & Degree certificate, as mentioned in application form.
 - Order/ letter in respect of equivalent Educational Qualifications claimed, indicating the Authority (with number
 and date) under which it has been so treated (in respect of equivalent clause in Essential Qualifications, if a
 candidate is claiming a particular qualification as equivalent qualification).
 - Caste/ Category Certificate, if belongs to reserved categories.
 - Persons with Benchmark Disabilities Certificate in the required format, if applicable.
 - Serving Defense Personnel Certificate or Discharge Certificate/PPO certificate in case of Ex-Servicemen (ESM) and NOC from the present Employer (If applicable).
 - Apart from above documents any other relevant document as mentioned in the application form for the purpose of document verification. Otherwise, the candidate will not be allowed to appear for the Written Competitive Examination.
- 8. Eligible Candidates can download their Admit Card for Written Examination after 07:00 PM on 01.08.2025 from the Institute's website. Admit Cards for Written Examination for candidates will also be available at CSIR-ITR. Hence, the candidates are requested to reach CSIR-Indian Institute of Toxicology Research, 31, MG Marg, Lucknow at 08:00 AM on 02.08.2025 (Saturday) with a valid Photo ID Proof along with its One Photocopy and One Passport Size Photograph of the candidate.
- The Selection of the candidate shall be provisional. The final selection shall be subjected to verification of the documents as declared by the candidate in the undertaking form at the time of Document Verification on 02.08.2025 (Saturday).
