Sub: Declaration of Final Results for Recruitment to the posts of Junior Stenographer vide IITR Advertisement No: IITR/2/2025 - reg.

Notification for filling up 04 vacancies of Junior Stenographer, was issued vide IITR Advertisement No: IITR/02/2025 dated 07.05.2025.

2. Total 14,386 applications were received against 04 vacancies. Out of 14,386, total 05,612 candidates found eligible for Competitive Written Examination by a duly constituted Scrutiny Committee. The final list of eligible candidates was issued vide IITR Notification No: A-12024/6/2025-R&A-IITR dated 06.06.2025.
3. The OMR based Competitive Written Exam for all the candidates who downloaded the admit card for the post of Junior Stenographer advertised vide Advertisement No. IITR/2/2025 was conducted on 18.06.2025 (Wednesday) at UPPSC Examination Hall, Lucknow.
4. Representations received from the candidates with regard to the tentative Answer Keys of Written Examination published vide Notification No: A-12024/6/2025-R&A-IITR, dated 19.06.2025 have been carefully examined and the Answer Keys have been modified wherever necessary. The Final Answer Keys published vide Notification No: A-12024/6/2025-R&A-IITR dated 24.06.2025 have been used for evaluation of OMR sheets accordingly.
5. As per Rule 6 of Section II of Part III of CSIR ASRP Rules, 2020:
 - i. The Proficiency in Stenography will only be qualifying in nature.
 - ii. The final merit list will be prepared on the basis of the performances of the candidates in the competitive Written Examination.
 - iii. The merit list will only comprise of those candidates those who have qualified the proficiency test in stenography.
6. Minimum threshold marks for qualifying the Competitive Written Examination for each category as decided by the duly constituted Selection Committee and published through this office notification of even no: A-12024/6/2025-R&A-IITR dated 12.06.2025 are as follows:

Category	Minimum Threshold Marks for Qualifying Written Examination
UR	50% out of 200 marks
OBC	45% out of 200 marks
SC	40% out of 200 marks

7. The Candidates who have scored minimum threshold marks i.e., 100/200 (50%) marks & above for UR candidates, 90/200 (45%) marks & above OBC candidates and 80/200 (40%) marks & above for SC candidates are kept in Merit Panel according to the marks scored in Written Examination subjected to qualify in Proficiency in Stenography (Skill-Test). However, the candidates were called in the ratio of 1:30 in order of their merit positions as per CSIR-IITR Web notification of even no: 12024/6/2025-R&A-IITR dated 12.06.2025 for proficiency in Stenography (Skill Test) but the candidates with equal marks in Written Examination placed in the merit list were also called for Proficiency in Stenography (Skill-Test).

8. Resultantly, 123 candidates were called for the Proficiency in Stenography (Skill-Test) in order of their merit positions for all the vacancies without repetition of Category Candidates in case of UR post. Details are as follows:

9. The Document Verification and Proficiency in Stenography (Skill-Test) of the candidates were held on 02nd July, 2025 at Government Industrial Training Institute (GITI), Aliganj, Lucknow in 02 different batches as per extant rules and CSIR circulars.
10. Accordingly, the Selection Committee took into consideration the following factors:
- The category wise number of vacancies
 - The marks scored in Written Examination by each candidate to work out the single merit list.
 - The relaxation in age availed by candidates belonging to reserved category (OBC/SC), if any.
 - Whether the candidate has qualified the Proficiency in Stenography (Skill-Test).
11. The Director, CSIR-IITR, on the basis of recommendations of the duly constituted Selection Committee as per the provisions under CSIR-ASRP Rules, 2020 has been pleased to approve the selection of the following candidates for appointment to the 04 posts of Junior Stenographer in Pay Matrix Level-4 of 7th CPC advertised vide IITR/2/2024

All the candidates appeared for the Competitive Written Examination held on 18.06.2025 can check their individual scores of Written Examination and Status (Qualified / Not Qualified) of Proficiency in Stenography (Skill-Test) held on 02.07.2025 through the link <https://iitr.res.in/En/Recruitment.aspx> available on CSIR-IITR website.
14. The Selection of candidates in the above list for the aforementioned post is **purely provisional**, subject to fulfilment of all the conditions stipulated in the advertisement and subsequent web notifications of CSIR-IITR. In case it is found at any stage, that the candidate does not fulfill any of the conditions of eligibility or any information provided by the candidate is found to be false or is not in conformity with the eligibility criteria mentioned in the advertisement / subsequent Web notifications published by CSIR-IITR or found ineligible on other grounds, the candidature of such candidate will be summarily cancelled/terminated at any stage, even after appointment without any further notice and appeal against such cancellation/termination will not be entertained.
